WHEREAS, the City of Melvindale authorized Hennessey Engineers, 13500 Reeck Road, Southgate, Michigan 48195 under the supervision of Nick Yuvan to prepare a Project Plan for the Michigan Department of Environment, Great Lakes and Energy (EGLE) Clean Water State Revolving Fund (CWSRF) and Drinking Water State Revolving Fund (DWSRF) Programs, which recommends the construction of the following projects: Lead Service Line Replacement Program, Allen Road Watermain Replacement, Flora Street Watermain Replacement, Sanitary Sewer Cleaning and Lining Program, Greenfield Road Pump Station Rehabilitation, and Greenfield Road Pump Station Secondary Storage Tank. The Final Project Plan for the CWSRF and DWSRF projects will be submitted to EGLE on May 1, 2023 and will be funded through the Michigan EGLE CWSRF and DWSRF Loan Programs; and
